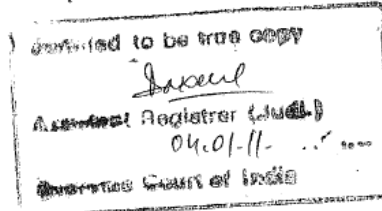


I.A. No.6:
