1. Condemned material will be sold out **“As is where is basis”** to the highest bidder.
2. The sale/bid value shall be deposited by the highest bidder on the same day in cash.
3. The interested bidders will have to enclose the DD/BC or in Cash to tune of Rs.10,000/- as Security/EMD in favour of Secretary, NCERT as refundable to the unsuccessful bidder except first highest bidder and second highest bidder.
4. The condemned materials can be inspected on any working day between 10.00 a.m. to 4.00 p.m. in the premises of NCERT.
5. The possession of condemned material will be given to highest bidder on the receipt of full amount of bid value after completing all the formalities
6. The highest bidder/purchaser will have to remove the condemned material within two days at their own cost. Thereafter, an amount of Rs.2000/- per day will be charged as ground rent.
7. In case, if the highest bidder does not lift the condemned material on the same day or even within the extended period of two days the bid security/EMD of Rs.10,000/- deposited by him shall be forfeited and liable for taking action against him i.e for re-sale of the condemned material at the risk and cost of the depositor.
